

## **Banks County FFA Breeding Doe Show**

---

1. The show will be open to all 4-H and FFA members through the 12th grade for 2020-2021 school year in the state of Georgia.
2. All Georgia state breeding doe show rules apply.
3. This show is open to any breed.
4. Goats will be weighed and divided into classes.
5. All goats must be dehorned or have horns tipped.
6. All goats must be entered by a state tag number. All goats must have a USDA approved Scrapie tag in the ear.
7. Exhibitors must show the goats they enter no substitutions. Substitutions of exhibitor can only be made if the exhibitor has 2 animals in the same weight class
8. Each exhibitor may show one goat in showmanship. The goat shown must be entered in the show, owned, and entered by the exhibitor.  
Showmanship classes will be determined by the number and grades of the exhibitors entered.
9. Only show officials and exhibitors allowed in the show ring.
10. Entry fees are \$25.00 for per animal. Showmanship is \$10.
11. All Entry fees are nonrefundable.
12. You may show off the trailer.
13. Pens will be available on first come first serve bases. Shavings will not be provided.
14. All goats must have an official health certificate (health paper), according to State Department of Agriculture Health Regulations.
15. Entry deadline is January 30, 2021. After January 30th only cash the day of check in will be excepted and entry fees will be doubled for weight class and showmanship (\$50 per animal and \$20 for showmanship).
16. The Banks County FFA Alumni or the Banks County Board of Education is not responsible for loss or injury.
17. Premiums – This show will be a jackpot show. Class and overall premiums will be based on the number of entries.
18. All decisions of the show committee is final.
19. The show committee reserves the right to disqualify any animal based on health concerns.
20. Please read the Covid health protocols.

## COVID-19 HEALTH & SAFETY PROTOCOLS
