Entry Fees:

The entry fee is \$25.00 per head (no maximum). Showmanship entry fee is \$10. Entries must be postmarked by **DECEMBER 31ST** or a \$25 late fee will apply.

Classes:

Does and Ewes will be shown separately in weight classes. Show order will be determined after receipt of all entries.

Age Requirements for All Junior Exhibitors:

Any exhibitor who is a high school senior or younger is eligible to show. There will be no minimum age requirement for exhibitors to enter in the show but the exhibitor must be able to control their animal without assistance.

Scrapie Tags/Health Papers: All does/ewes are required to have a scrapie tag at weigh-in that will be used for identification. Health papers will be required at check-in.

Liability:

Show officials, show management or anyone assisting with the show will in no case be responsible for any loss or damage that may occur. Each exhibitor will assume all liability in case of any death, injury or damage to property caused by or to his/her animal.

Concessions: Breakfast and Lunch will be served onsite at the concession stand.
