RULES PLEASE READ!!

General Rules: The show chairman and committee reserve the final and absolute right to interpret these rules, settle and determine all matters, questions and differences arising from or connected to the Southern Watermelon Crawl Show. Any exhibitor who violates the rules will forfeit all privileges and be subject to such penalties as the committee may order. The judge's decision will be final. No protest will be allowed. No reversal of decision will be considered. This competition is open to all 4-H & FFA students. There is no limit to the number of animals an exhibitor may enter in the show. Animals will show by age according to sex and weight. The show committee reserves the right to combine or split classes as needed. **NO ALCOHOLIC BEVERAGES ALLOWED ON FFA/FCCLA PREMISES, ESPECIALLY THE BARN AND SHOW RINGS!**

All entries must be postmarked by **JULY 5th, 2026**. The entry fee is \$30 per goat. Late entries will be accepted with an additional \$5 per goat per show, late fee with no discounts. **The pen fee is \$18 per pen for each pen used, including tack pens if you set even a bucket / bag/ rope/ anything in an extra pen the facility charges \$18 for that pen. PENS WILL BE ASSIGNED.** The pen fee includes first bedding only and must accompany the entry form. Additional shavings will be available for purchase at \$9 per bag. **ALL FEES ARE NON-REFUNDABLE.** You may show off your trailer if you prefer.

Health Requirements: Georgia and Out of State goats must enter on certificate of veterinary inspection issued within 30 days of the exhibition. All goats must be identified with USDA approved individual animal identification to flock of origin. The statement must be recorded on the certificate of veterinary inspection for all goats: "To the best of my knowledge. The animals being exhibited are free from any clinical signs consistent with those of foot rot, scabies, contagious ecthyma (sore mouth), cutaneous fungal lesions, scrapie or any other infectious or disease." Goats may be inspected at the show facility for infectious and contagious diseases and those suspected of having disease will be removed from the show facility.

Liability: The exhibitor is responsible for the safety, health and wellbeing of their goat. The Southern Watermelon Crawl assumes no responsibility and or liability for any animal(s), property(s), and/or person(s) attending this event. No representative or attendee of The Southern Watermelon Crawl, or associated business or individuals, participants or spectator will be held responsible for any illness, injury, damages or loss of animal, person, or property in conjunction with the event of facilities. All who attend do so at their own risk. By entering the show, you agree to hold harmless all parties for any losses or damages that may occur.

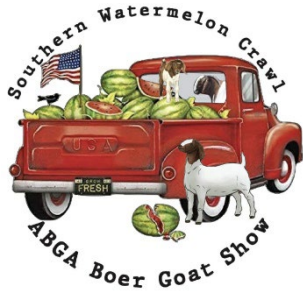
